## Police Report Summary Briefing

**Period Covered:** Monday, June 10th to Sunday, June 16th, 1985

**Location:** Pennsauken, New Jersey

**Overview:** During the week of June 10th to June 16th, 1985, Pennsauken experienced a series of small-scale crimes alongside several notable incidents requiring police attention.

**Small-Time Crimes:** Throughout the week, there were multiple reports of petty thefts, vandalism, and disturbances in various neighborhoods of Pennsauken. These incidents included:

- Several reports of vehicle break-ins in residential areas, with items such as radios and personal belongings stolen.

#### 3. Explosion in Pennsauken Shores

- **Date:** Sunday, June 16th, 1985
- **Reporting Officer:** Officer Grady Gladhands, Badge #4567
- **Details:** Residents in the Pennsauken Shores region reported an explosion on Sunday. Investigation led to the Whitmoore Chemical Company, which acknowledged a problem with a nitrogen tank but denied providing additional information to the police. No injuries were reported, but the incident caused concern among local residents.

### Police Response and Actions:

- Increased patrols have been implemented in neighborhoods experiencing higher rates of small-time crime.
- Investigations into the drowning incident at Pennsauken Pool are ongoing, including interviews with witnesses and review of surveillance footage.
